At this challenging time, I urge the TTUSD Board of Education Trustees to continue with the distance learning model. Given the extension of the Regional Stay at Home Order and the post-holiday surge, I believe the January 19 and January 25 target dates are no longer in the best interest of our community.

Based on analysis of current data by a team of scientists, statisticians and epidemiologists, the Regional Stay at Home Order was extended four weeks, to the end of January. The extension is essential to managing hospital system capacity and the current post-holiday surge. I urge you to honor the order and not consider returning TTUSD schools to an in-person model until after the Regional Stay at Home order is lifted.

Data shows that children are often asymptomatic but are capable of unknowingly spreading virus. This phenomenon may have contributed to TTUSD having to return to distance learning after just a few weeks of hybrid in person learning last fall.

Please consider the model being implemented by the Cherry Creek School District (CCSD), near Denver, CO.* The December 15 CCSD letter to the community included the plan to open with in-person learning in January. The current surge led to a change of plan described in The Denver Post article noted below. The new plan includes getting both doses of vaccine administered to the CCSD teachers and staff by the end of February. This will allow the schools to safely open, with masks in March.

Covid-19 has been going on for a long time, we are all tired of it and the children need to experience in person learning. But this is not the time to let our guard down, it's time to double down, to keep one and all safe and healthy and begin in person learning when the time is right.

We would like to urge the TTUSD board to continue distance learning until our county is no longer in the Widespread tier of COVID-19 transmission, until the Stay-at-Home order is lifted for the Sacramento region of California, and until TTUSD staff can be fully vaccinated.

Our recent experiences scheduling a COVID-19 test show that in our locality, testing is NOT easy and fast. Scheduling and results for such tests have taken us at least 12 days from onset of symptoms; which is more than the 10-day quarantine recommended by many. Friends in the Bay Area have shared that their children's schools test ALL staff and students weekly. Without rapid and frequent testing, how can we have any hope of an accurate understanding of whether or not the virus is circulating in our schools or in our community?

In addition, vaccine roll-out is proceeding more slowly than expected. In the interest of keeping teachers and staff safe, and in the wake of this unprecedented surge of new cases and deaths in the state of California, we believe it would make more sense to wait to return students to inperson learning until TTUSD staff and teachers can be vaccinated.

I am writing to the school board on a very important and relevant issue regarding the return to school. I know the district is working very hard to do what's right for the health of the community and prevent the spread of COVID 19. Not only should the health safety of teachers and students be a priority, but another extremely vital factor seems to be being over looked......the mental health impacts of school closures. There are many factors that are considered with schools opening, more than the public and us parents are aware. One thing I am very aware of however as a parent is how school closures are affecting the mental health of our children. Personally this has shaken our family life and I want the board members to know how important it is to figure out a way to safely open and KEEP schools operating and kids in the classroom away from distance learning. After the abrupt closure after thanksgiving of TTUSD schools, my middle school child sulked sadly back into strict distance learning, and started to have worsening depression with thoughts of self-harm. Finally after a few weeks a mental health crisis occurred and evaluation at a behavioral health hospital was needed for active suicidal thoughts. My child identified this was linked to the stress of distance learning and how much he hates it, topped with other family life stressors related to COVID, to the point he felt ending his life would be better than what he was going through each day. Not seeing friends, being isolated, not being able to engage in learning and interact with people and teachers has taken its toll on our students and children. The school system is amazing and goes above and beyond in its support that it offers for families and mental health and we appreciate it greatly. Unfortunately the health system is broken and our community is lacking adequate mental health resources for children. This has been a disheartening realization as a mom who works as a nurse leader in the local health care system. I am begging you, as a very concerned parent and community member, to make the mental health of our students a priority equally as much as mitigating the spread of

the pandemic. Please get schools open as much as possible, sustaining our community and saving lives not only depends on protection from COVID, but equally the mental health of our students and families.
