I am the parent of a 13-year-old student at Alder Creek Middle School and a year-round resident of Truckee for 24 years.

This has been one of the most challenging and disruptive years in public education. Most teachers, many of whom have children of their own, will tell you that they had to work harder this past year than they've ever worked in their lives. Next year could be even more challenging as schools attempt to catch kids up.

As Truckee properties change hands and tax revenue swells, classroom sizes are also growing. There are 4,177 children enrolled in our district but unfortunately a dwindling number of educators can afford to live here. You have an opportunity to alleviate this problem and I hope you will do so.

This past year, some parents advocated for an early return to full, in-person instruction. This goes to show just how needed and valuable teachers are to our community. And let's not forget, teachers did go back to in-person instruction before there was a vaccine. The teachers and their union were willing to sacrifice their safety for the good of our children. Truckee teachers are consummate professionals who practice education the way a doctor practices medicine. They are educating our children much like pediatricians treats them.

Please show teachers that you respect and appreciate them by negotiating in good faith and allowing a raise that is in proportion to the increased cost of living in Truckee. Thank you.
