A description of how the funds will be used to increase or improve services for foster youth, low-income students, and English learners to improve A-G eligibility

TTUSD will improve services for foster youth, low-income students, and English learners to improve A-G eligibility by implementing the following: Sharpen focuses on A-G readiness (A-G courses, dual enrollment, AP classes), data collection, program coordination/implementation, college as a post-secondary option, college tours, and middle school transition for key student groups (foster youth, low-income students, and English learners) by increasing counseling support at high schools with additional counselors and career center technicians.

Conduct transcript analysis to review student access and success in A-G courses. Results will be reviewed for key student groups (foster youth, low-income students, and English learners, disaggregated) as well as holistically (aggregated). School leadership teams and curricular teams will review the data and identify additional areas for action to increase access and success for all students, including key student groups.

Progress monitoring will continue for all students, including key student groups (foster youth, low-income students, and English learners), to ensure access to A-G coursework.

A description of the extent to which all students, including foster youth, low-income students, and English learners, will have access to A-G courses approved by the University of California.

Access will continue to be provided to A-G courses for all students, including those in key student groups (foster youth, low-income students, and English learners) with the additional course planning listed above.

The number of students who were identified for opportunities to retake A-G approved courses in which they received a "D", "F", or "Fail" grade in the 2020 spring semester or the 2020-21 school year and a description of the method used to offer the opportunity retake courses.

Number of Students: 268

Students at NTHS who receive a D/F in the fall semester are first offered an opportunity to improve their grades through a ski/skate intersession contract. If a student does not qualify for a contract, does not successfully complete a contract, or fails a spring semester, they are offered summer school to remediate their grade. Students can remediate 10 credits or two semesters over summer school. If summer school is not a successful option, students are scheduled into the class again to repeat it for a year-long class, or they can sign up to take a credit recovery class either during the school day or after school to make up the credits through the online Edgenuity courses.

At THS, students are offered summer school to remediate their grades from either the fall or spring semester. Students can remediate 10 credits or two semesters over summer school. If summer school is not a successful option, students are scheduled into the class again to repeat it for a year-long class, Student Success class, or they can sign up to take a credit recovery class either during the school day or after school to make up the credits through the online Edgenuity courses.

A description of how the plan and described services, and associated expenditures, if applicable, supplement services in the Local Control and Accountability Plan and Learning Recovery Plan.

LCAP, ELO, and other funding sources are used to provide summer school and credit recovery options. The A G Completion Improvement Grant funding will enhance and extend these plans, adding additional academic support in A-G approved courses, additional counseling support, and transcript audit support.
