General Education Services

1. The Tahoe Truckee Unified School District provides home to school transportation for qualifying pupils in Transitional Kindergarten, Kindergarten, and Grades 1-12. Pupils may qualify according to their proximity to their approved home school of attendance. BP 3541 states, "students shall be eligible for transportation service to and from school if the distance between their school-established bus stop and the school is beyond the minimum listed below":

Grades TK-3: three-fourths mile from school of attendance. (Calculated by "As The Crow Flies.")

Grades 4-8: one mile from school of attendance. (Calculated by "As The Crow Flies.")

Grades 9-12: two miles from school of attendance. (Calculated by "As The Crow Flies.")

The Tahoe Truckee Unified School District Transportation Service Plan provides free transportation services for qualified low income pupils who reside within the approved service areas for the following school locations: Alder Creek Middle, Donner Trail Elementary, Glenshire Elementary, Kings Beach elementary, North Tahoe High, North Tahoe School, Sierra Expeditionary Learning, Sierra High, Sierra Teen Education Parenting Program, Tahoe Lake Elementary, Truckee Elementary, Truckee Elementary Pre-school, Truckee High, and Truckee River School.

Special Education Services: If transportation is identified in the Individual Education Plan (IEP) as a related service, transportation and additional transportation services as needed is provided for free and the school bus may be utilized to provide the transportation service.

pupils have been approved, a complete transportation services application must be submitted to enable the Transportation Department to have the information necessary to safely transport pupils, including, but not limited to:

Once services are approved, the transportation application is submitted and processed, transportation will contact the parent guardian with the Transportation Safety Plan including bus stop locations and times.

Consultations:

Although not required, below is a description of ongoing consultation with classified staff, teachers, school administrators, regional local transit authorities, local air pollution control districts and air quality management districts, parents, pupils and other stakeholders.

The Tahoe Truckee Unified School District has continued to gather input from key educational partners, including state and county agencies and parents/guardians in relation to the transportation of District students. The process for soliciting input is varied and includes meetings (in-person and virtual), online surveys, public feedback via phone, email, and School Board meeting comments. To date, TTUSD has consulted with the Northern Sierra Air Quality Management District, and the Placer County Air Pollution Control District. In addition, TTUSD has consulted with the Placer County Department of Public Works, Transit Division, to determine areas where transportation services may be coordinated for TTUSD students, including students who may be experiencing low income households. TTUSD also reviewed a staff and community survey, solicited input at school site council meetings during LCAP agenda items, and provided a school board public comment opportunity in person and remotely related to servicing low income students to help develop the Transportation Services Plan. Additionally, the District's Homeless and Foster Youth Liaison and transportation department staff work directly with families living in homelessness and foster youth resource parents and social workers to elicit input on transportation department policies and procedures to reduce barriers to school attendance.
