## **RESOLUTION NO. 21-2022-2023**

## A RESOLUTION OF THE BOARD OF EDUCATION OF THE TAHOE TRUCKEE UNIFIED SCHOOL DISTRICT

## **Regarding Adoption of Emergency Proclamation**

WHEREAS, on March 9, 2023, pursuant to Section 2.50.060(b) of the Town of Truckee ("Truckee") Municipal Code, the Town Council of Truckee proclaimed a local state of emergency regarding a forecasted atmospheric river storm event ("Storm") and previous severe winter storms resulting in conditions of extreme peril to the safety of persons and property, within all areas of said Town, caused by extreme levels of rain, snow and wind.

**WHEREAS**, the Town of Truckee is located within the Boundaries of the Tahoe Truckee Unified School District ("District");

**WHEREAS**, the District also experienced the same conditions of extreme peril to the safety of persons and property, within all areas of the District Boundaries including Truckee and unincorporated areas of Placer, Nevada, and El Dorado Counties, caused by extreme levels of rain, snow and wind.

**WHEREAS**, these conditions were beyond the control of the services, personnel, equipment, and facilities of the District, and;

**WHEREAS**, these conditions have resulted in the emergency closure of District's schools for multiple days; and

**WHEREAS**, as a result of the Storm, the District incurred additional costs not included in the annual budget in the following areas:

- -Snow Removal
- -Overtime for essential staff
- -Food loss from power outages
- -Additional costs associated with mandatory non-workday ("call-off")
- -Personnel, vendor, and material costs from repairs of damaged buildings and infrastructure

**WHEREAS**, the District requests to be eligible for emergency funds made available to reimburse these additional costs

**NOW, THEREFORE,** the District declares that a local emergency now exists throughout said District;

**IT IS FURTHER PROCLAIMED AND ORDERED** that a copy of this declaration be forwarded to the Governor of California with the request that he proclaim a state of emergency for the Town of Truckee and jurisdictions within the Boundaries of the District, and further that the Governor request a Presidential Declaration
