District boundaries stretch from Hobart Mills, eight miles north of Truckee, to Emerald Bay, near South Lake Tahoe; and from Cisco Grove, twenty miles to the west, to Floriston, fifteen miles to the east.

School Description

Tahoe Lake Elementary serves Transitional Kindergarten through 5th-grade students. We foster a love of learning and the confidence to achieve through a challenging and differentiated education for every child. We supplement core studies with explorations and enrichment including hands-on science with an environmental focus, technology, music, art, outdoor education, and PE.

At Tahoe Lake Elementary we value each individual student. 2023-24 School Safety Plan

The safety and well-being of students and staff is the primary concern of Tahoe Lake Elementary. All visitors to the campus must check in at the office via the Raptor System and wear a visitor's pass at all times. Supervision is provided to ensure the safety of each student before school, during breaks, at lunch, and after school. Supervision is a responsibility shared among support staff, teachers, and the administration.

The Comprehensive School Safety Plan is revised every year by staff and the Site Council. The Safety Plan is reviewed with all staff members at the beginning of each school year. Key elements of the Safety Plan focus on the following:

- School rules & procedures
- Harassment policies, including bullying and sexual harassment
- Current status of school crime
- Notification to teachers
- Child abuse reporting procedures
- School-wide dress code
- Policies related to suspension/expulsion
- Disaster procedures/routine & emergency drills
- Safe ingress & egress of pupils, parents, & school employees
- Healthy Kids Survey Results
- ALICE training safety protocol

The school is in compliance with the laws, rules, and regulations pertaining to hazardous materials and state earthquake standards. The school's disaster preparedness plan includes steps for ensuring student and staff safety during an emergency. Fire, disaster, and intruder drills are conducted on a regular basis throughout the school year.
